



## **Rebuild Alabama Act Bid Advertisement Greene County**

Greene County is taking sealed bids for labor, equipment, materials and any incidentals required to complete the work required for the RA-GCP 01-01-2022; (SITE 1) FULL DEPTH RECLAMATION AND J/G TREATMENT ON MULTIPLE SECTIONS ON CR-117, (SITE 2) FULL DEPTH RECLAMATION AND J/G TREATMENT ON MULTIPLE SECTIONS ON CR-120, (SITE 3) FULL DEPTH RECLAMATION, J/G TREATMENT AND TRAFFIC STRIPE 0.9 MILE ON COUNTY ROAD 154. This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2 and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be marked with the word "BID" on the outside of the bid package along with Bid Proposal for the RA-GCP 01-01-2022; (SITE 1) FULL DEPTH RECLAMATION AND J/G TREATMENT ON MULTIPLE SECTIONS ON CR-117, (SITE 2) FULL DEPTH RECLAMATION AND J/G TREATMENT ON MULTIPLE SECTIONS ON CR-120, (SITE 3) FULL DEPTH RECLAMATION, J/G TREATMENT AND TRAFFIC STRIPE 0.9 MILE ON COUNTY ROAD 154, the bid date and the Alabama General Contractor's License Number.

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances and codes of the U.S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

Sealed bids will be received by the Greene County Public Works at the Greene County Highway Department, 521 Prairie Ave., Eutaw, AL 35462, until 10:00 A.M. Central Time on March 16, 2022 and the publicly opened as soon thereafter as practicable. Award will be made at the next regularly scheduled meeting of the Greene County Commission.
