## **INVITATION TO BID**

Blount County is taking sealed bids for its FY 2023 annual work program. Competitive bids are requested for materials and any labor, equipment, and incidentals required to provide those materials to Blount County on the following items:

These bids are intended to comply with the Rebuild Alabama Act, No. 2019-2, Alabama Code Title 39, the Alabama Public Works Law, and/or Alabama Code Title 41, the Alabama Competitive Bid Law. Bidders shall be required to comply with afore mentioned provisions regardless if the requirements are explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be sealed and marked as instructed in the bid request packet.

The contractor or supplier shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and Blount County, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

Sealed bids will be received by the Blount County Commission at 220 2<sup>nd</sup> Avenue East Oneonta, AL 35121 until 9:00 AM Central Time on Wednesday, July 20, 2022, and then publicly opened as soon thereafter as practicable.
