### **NOTICE OF BID OPENING**

#### **THE INVITATION PACKAGE**

**NOTICE IS HEREBY GIVEN** that Sumter County shall receive and open bids for the purchase of zero (0) or more cubic yards of lightweight aggregate at the Sumter County Commission Courthouse Annex, P.O. Box 70, Livingston, Alabama, at 10:00 a.m. on Wednesday, September 4, 2024.

Time is of the essence in submitting bids and only bids received in the Sumter County Commission Courthouse Annex by 10:00 a.m. on September 4, 2024 shall be opened and considered. Bidders and other interested individuals are invited to attend the bid opening.

Each invitation package for lightweight aggregate includes: this invitation to bid, the written bid specifications for the lightweight aggregate to be bid, and a Bid Submittal Form to be used in submitting your bid. Bidders should verify that they have received all pages of the invitation package. If there are any omissions, the Bidder should contact the County by mail, fax, or e-mail to request missing pages. It is the responsibility of the bidder to make this request in sufficient time to prepare and submit the bid in time for the bid opening.

Bidders should carefully read and comply with all parts of the invitation package, including all attachments.

# PREPARING AND SUBMITTING BIDS – (PLEASE SUBMIT BIDS IN DUPLICATE.)

All bids must be typed or hand written in ink **on the attached Bid Submittal Form.** Bids submitted in pencil and bids not submitted on the Bid Submittal Form will **not** be considered. Only information contained on the attached bid form or otherwise requested or required will be considered in evaluating bids.

Each bid for lightweight aggregate included in the bid package must be submitted on the Bid Submittal Form and forwarded in a separate envelope with the bid item and item number clearly identified on the outside of the envelope. Envelopes containing a "no-bid" shall also include the words "NO BID" on the outside of the envelope. Facsimiles and e-mails will not be accepted. Bids submitted by "Express/Overnight" services must be in a separate inner envelope or package sealed and identified as stated above. All bids must be received in the County office prior to the bid opening. Bids received after the deadline will be returned unopened.

## **BID SPECIFICATIONS**

The specifications for lightweight aggregate are attached hereto. Any use of specific names and/or model numbers in the attached specifications is not intended to restrict the bidder or any seller or manufacturer, but is included solely for the purpose of indicating the type, size, and quality of materials, product services, or equipment considered best adapted to the use of the County.

#### **BIDDER QUALIFICATIONS**

All bidders must be in conformance with any applicable federal, state, county and municipal laws, regulations, resolutions and ordinances, including but not limited to, licensing, permitting, and taxation requirements. Such evidence or documentation, including a completed W-9 form, must be submitted with the bid. All bidders shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, Act No. 2011-535 of the Alabama Legislature; moreover, all bidders will need to certify that they use E-Verify to confirm employment eligibility for all of their employees.

#### **BID AWARD**

The Sumter County Commission will award all contracts at a meeting of the Sumter County Commission. Any and all bids submitted in compliance with this invitation to bid shall be considered, and award will be made to the lowest responsible bidder meeting bid specifications as determined by the County in compliance with Alabama law. All factors contained in each invitation package will be evaluated in determining the successful bidder, and any omissions of the stated requirements may be cause for rejection of the bid submitted. The County reserves the right to reject any and all bids, to waive any informality in bids, and to accept in whole or in part such bid or bids solely at its discretion.

The contract period will be one year with an option to renew for a second and third year under identical price, terms, and conditions upon the mutual consent of the vendor and the County. Any renewal contract shall be approved in writing by the vendor and the County prior to the expiration of the existing contract.

By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting there from.

In the event that lightweight aggregate meeting this bid specification is available to the County through governmental joint bidding during the contract, the County reserves the right to purchase lightweight aggregate via governmental joint bidding when it is in the best interest of the County to do so.

## Lightweight aggregate (LWA)

All lightweight aggregate shall meet or exceed specifications as outlined in the Invitation to Bid and as set out below, and shall comply with each of the following:

- Materials furnished for use shall conform to the appropriate requirements of Division 800, Materials, with specific reference to Section 801.12 of the Alabama Department of Transportation Standard Specification for Highway Construction, 2022 Edition. This aggregate shall have a dry loose unit weight of 30 35 lbs/cubic ft, 100% passing a 3/8" sieve size, 10 40% passing a #4 sieve size, and 0 5% passing a #8, #16, #50, and #100 sieve size.
- Bid price shall include delivery f.o.b. plant or f.o.b. Sumter County.
- All orders should be truckload quantities.

All orders shall be received at the location identified by the County within ten (10) calendar days from the date of order. In the event the  $10^{th}$  day falls on a weekend or holiday, the delivery must be by the next business day thereafter. All lightweight aggregate not delivered within this time period will be reduced in price by 10%.
