Note #5: All school zone signs shall be fluorescent yellow as required by the current edition of the MUTCD.

#### **INSURANCE REQUIREMENTS:**

Prior to any goods being delivered or any services being rendered to Escambia County, the following insurance must be met and documents on file in the office of the Escambia County Commission:

- Certificate of Insurance evidencing general liability insurance in an amount of no less than one million dollars and workmen's compensation insurance.
- The certificate of insurance must include a waiver of subrogation against Escambia County for both general liability and workmen's compensation insurance.
- "Escambia County, its employees, agents and assigns," must be listed as additional insureds on the certificate of insurance.

E-VERIFY REQUIREMENT: In accordance with the Code of Alabama, 1975 as amended, §31-13-9, the successful bidder, "shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama and shall attest to such, by sworn affidavit signed before a notary." Additionally, the business entity "shall provide documentation establishing that [it] is enrolled in the E-Verify program" and that during the contract period, it "shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations." This section shall also apply to subcontractors. The successful bidder shall provide proof of enrollment in the E-Verify program before receiving a contract.

The price stated in bid should be based on delivery to various locations within Escambia County, Alabama, with approximate delivery date included.

All bids should be sealed with subject matter marked plainly on outside of envelope.
