



# Rebuild Alabama Act



## Advertisement for Bid Madison County

Madison County is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required in the bid package titled, ***Slaughter Road Improvements at the Intersections of Eastview Drive and Castle Drive***, dated October 2024. This bid is intended to comply with the Federal Provisions of the American Rescue Plan Act (ARPA), Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be marked with the word "BID" on the outside of the bid package along with a completed Bid Form, Bid Bond, Unauthorized Alien Forms, and the Alabama General Contractor's License Number. Required bid documents can be found in Section 6 of the bid package. **An optional Pre-Bid meeting will be held at the Madison County Public Works office located at 266-C Shields Road, Huntsville, Alabama 35811 at 2:00 PM Central Time on November 13, 2024.**

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

**Sealed bids will be received by the Madison County Commission on the 7<sup>th</sup> floor of the courthouse, located at 100 Northside Square, Huntsville, Alabama 35801 until 2:00 P.M. Central Time on November 20, 2024**, and then publicly opened as soon thereafter as practicable. Award will be made at the next regularly scheduled meeting of the Madison County Commission.
